We help on average, less than 20 Veterans each month, though that number is starting to quickly grow. ## **Project Overview**

It is our objective to grow from handling less than 20 Veteran cases each month, to 100 within the next few months of our expansion efforts.

Currently, we have an average cost basis of \$1,000 per Veteran. This is the hard-cost of helping each Veteran with “Triage Care,” which requires (on average) \$1000 in immediate “bail-out” funds and efforts, for issues such as late rent / facing eviction, vehicle repairs, payments or repossession issues, utility bill payments to keep service from being shut off, or having them turned back on. These are just some examples of the immediate financial issues that we cover in the triage help process provided by Valor for Veterans, though it doesn’t stop there.

At this point, the Veteran is assigned to a resource in our network (often times a specialist) where they receive further care, guidance and support based on their unique situation and what brought them to where they are.

We have begun our expansion plans with the “V4V Triage Fund” in pursuit of our immediate goal of expanding our efforts of helping 100+ Veterans per month - and growing from there.

We are looking for enterprise sponsors or supporters to help us with funding the Triage Fund in order to help fuel our efforts and growth; ideally looking for monthly supporters who will supply the Fund with a monthly sum, allowing for the ongoing financial support of our triage efforts.

## **WHAT MAKES US SPECIAL**

All Veteran cases are showcased in real-time on our website, and real time details and updates show the process through-to-solution, for each Veteran case. Thus, accountability and performance reviews are built right in.

We are a “performance” based and driven organization, and so, we are excited to work on a “performance” basis. Our objective is to go from 20, to 50, to 100 Veteran cases resolved (in triage) each month.

With help to fuel our Fund, we have the skills, manpower and systems scaled to meet the objective. Please make the decision to support our effort. Please help fuel the Fund. We look forward to your input, review and your decision. Thank you.

**Note:** The cost to help each Veteran case includes roughly 25% in operational overhead costs.
